On behalf of the Fort Washington Food Pantry, I am writing to thank you for generous contributions that you delivered to our Thanksgiving distribution on November 19. I was not there that morning but I understand you brought meat from Share, toothbrushes and other contributions. It must have been a very exciting day for the pantry. The Boy Scout food drive brought us approximately 2000 cans and boxes of nonperishable foods. Our pantry storage shelves were full to overflowing. Our clients know that food drives bring in a greater variety of items than we usually offer. They came to see what they could get even though we told them that we had no holiday turkeys.

Turkeys are no longer available in quantities at bargain prices. Fort Foote Baptist Church gave out 160 turkeys for which they paid 99 cents per pound. The average turkey cost \$11. We knew in advance that we would be unable to supply our clients at reasonable cost so we gave their names to the Redskins distribution at Fed Ex Field. We also told them how to register for Fort Foote's distribution.

Our pantry was able to get rolled beef roasts from Share for \$6 each. We also had smoked ham quarters from the food bank. Unfortunately our volunteers began distributing some of the roasts 2 weeks early. When our holiday pantry opened we certainly did not have enough roasts for the 66 families who came. During the course of the morning, nearly all the meat in our freezers was given out. Your contributions came on the perfect day.

We are getting ready to take our largest vehicle to the food bank this week. We need lots of meat and fresh produce. The food bank was closed for a long weekend and hopefully they are busy unloading trucks full of donated food right now. All the pantries and soup kitchens in the area will be counting on them to restock shelves. It never ends with so many hungry people.

Thank you again for all your help. We remain a 501(c)3 organization through St, John's Episcopal Church. We also invite you to our December 10 Christmas at the Creek concert. Local singers, Grace Griffith and Lynn Hollyfield of Accokeek are joined by Carrie Creed, Jody Marshall and talented instrumentalists. The music is mostly Celtic. The concert starts at 7:30 PM and will be held in historic St. John's Church. Donations of \$10 per person support the pantry in the coming year.

On behalf of the Fort Washington Food Pantry, I am writing to thank you for generous contribution of food. We were pleased to receive your contribution during our distribution last Saturday. I am sure that the food was put out right away. While we had some very nice produce, our meat supply was less interesting.

We had a bit of a scare last month when the food bank raised its rates. We are required to contribute a relatively small amount per pound of food that we take. For the first part of the year we paid 15 cents per pound but that price was raised to 19 cents. Of greater consequence was the fact that previously free fresh produce would now cost 10 cents per pound. Our cost of \$5000 per year was about to double.

Fortunately, the food bank realized that some food pantries would be unable to continue. Some pantries with very low funding manage to distribute large amounts of produce contributing greatly to the nutrition of our neighbors. We read last week about a large contribution to pay for the produce costs. That is so wonderful that we will be able to get all the produce our trucks and refrigerators can handle.

Could you order that instead of the Value Packages? Either way, I know Share food is always popular.
